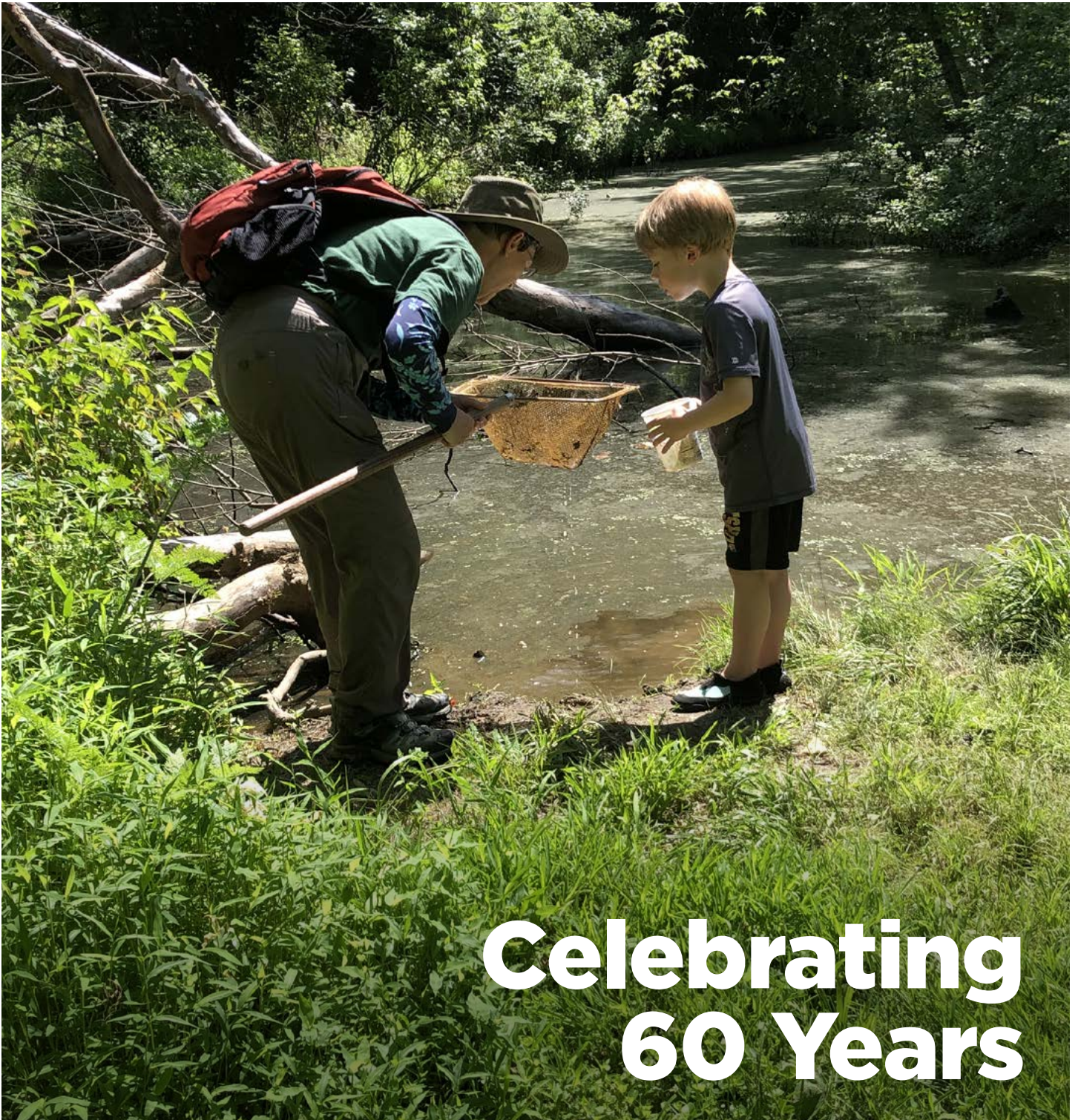

From the Executive Director

Dear Members, Volunteers, and Friends,

I'm pleased to share our Annual Report for 2024, a landmark year for Delaware Nature Society. Last year, we released our Strategic Plan entitled *Life Depends on Us* after engaging hundreds of stakeholders through retreats, surveys, interviews and meetings to provide us with guidance and direction for the future.

Throughout 2024, we also celebrated our 60th Anniversary by pairing accomplishments from the past with aspirations for the future. Every two months we highlighted a new theme with special anniversary events and programs.

- **Grow With It** celebrated plants and biodiversity with our spring Native Plant Sale at Coverdale Farm and a new mini-sale and open house at Abbotts Mill Nature Center.
- **Water Is Life** recognized our Clean Water for Delaware successes with special events stressing the importance of water resources like the wetlands of the Christina River and floodplains of the Red Clay Creek.
- **All Things Winged** raised awareness about bird conservation and pollinator habitat with an “On a Wing and a Beer” collaboration and events in Rehoboth, and the Monarch Migration Celebration in Wilmington.
- **Food for Thought** kicked off with “A Taste of Coverdale” highlighting the special places and food of Coverdale Farm Preserve.
- **Back to the Land** closed the year with a Hollyday Wreath Celebration at Abbotts Mill Nature Center and Community Science Symposium at Ashland Nature Center.

Thanks to these themes and events and the support of members and donors like you throughout the year, 2024 gave us a renewed sense of the impact of our work and direction for the future.

We also made impressive progress on the initiatives in our new strategic plan in 2024 – and were recognized as a *Superstar in Business* by the Delaware Chamber of Commerce! We expanded programming for early learning at Coverdale and Ashland and paddling opportunities at the DuPont Environmental Education Center. We worked up and down the state, renovating the Nature Center at Abbotts Mill, growing the network of pollinator habitats across the City of Wilmington, and talking to people about renewable energy and other climate solutions. **In 2024, DelNature sites and programs reached over 132,500 people, including over 35,000 participants in school and group programs.**

Thank you for your support and partnership making these accomplishments possible. Together we can make the next 60 years as impactful as the first!

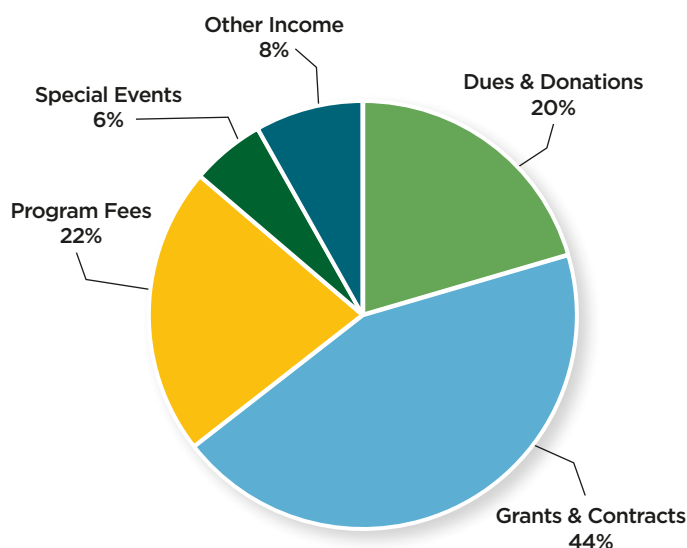

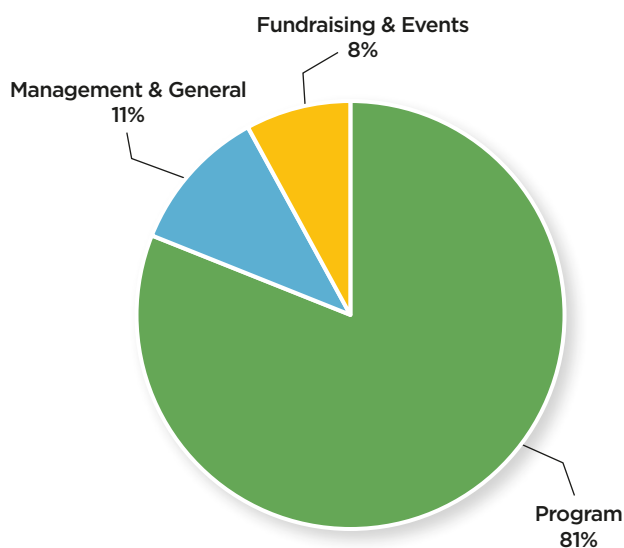
2024 Financial Summary

Our mission is to connect people and nature to create a healthy environment for all through education, conservation, and advocacy.

Highlights from 2024

In 2024, we celebrated our **60th Anniversary** with a new strategic plan, a *Superstars in Business* award from the Delaware Chamber of Commerce, and a series of programs and events celebrating the past and highlighting priorities for the future on five key themes: *Grow With It*, *Water is Life*, *All Things Winged*, *Food for Thought*, and *Back to the Land*.



Partnerships in 2024 included a beer collaboration with Dogfish Head Brewery's Beer and Benevolence program promoting bird and pollinator conservation. We worked together to create **On A Wing and A Beer**, a limited-edition brew featuring bird-friendly coffee and pollinator-friendly bee balm from Coverdale Farm Preserve.

Early Learning blossomed in 2024, with an expansion of Knee-High Naturalist programs at Coverdale Farm Preserve, Ashland Nature Center, and Abbotts Mill Nature Center, and Wilmington preschools by DuPont Environmental Education Center staff. Lessons and experiences in nature set young learners up for a lifetime of learning and exploration.



With the support of corporate, community, and government partners, we added almost 20,000 **Native Plants** to yards, urban gardens, and natural areas across Delaware in 2024. We expanded our network of community garden partnerships in Wilmington, our native plant sale to include Abbotts Mill Nature Center, and had 128 people register new Certified Wildlife Habitats.

Started in 2024, the **Wood Thrush Conservation** Initiative seeks to understand the threats faced by this species of conservation concern and to engage more people in its conservation. Over the year, 26 birds were radio tracked to monitor migratory patterns and identify critical habitats utilizing the MOTUS network that includes towers at Bucktoe Creek Preserve, the DuPont Environmental Education Center, and Abbotts Mill Nature Preserve.



Prescribed burns are an important part of our **active ecological management** of forests and meadows. Our trained staff are part of a broader collaborative partnership to restore habitats regionally through controlled burns, including the meadows at Coverdale Farm Preserve and forests at Flint Woods Preserve in 2024.

Our top advocacy successes in 2024 were on **climate action**. Passage of the Energy Solutions for Delaware Act (SB 265) requires the State Energy Office to play a more proactive role in determining how wind power is developed off our coast, and passage of Senate Bill 237 requires local governments to consider climate effects in planning decisions.



In 2024, we expanded **work-to-learn** opportunities, hosting our first official cohort of farm apprentices – paid positions at Coverdale Farm Preserve that provide training on regenerative farming through work experience. We also supported the University of Delaware in training the largest cohort yet of Master Naturalists, who gain skills through hands-on projects at our sites and elsewhere.
